#### **Presentation**

Lynch Elementary Principal, Ryan West along with teachers, Tami Curry, Talia Leonard and Devon Weaver presented information on how Lynch is working to reach District Goal #1: 100% of all K-5 reading and math units have KUDs aligned to CCSS as evidenced in lesson and unit plans. A companion document links curriculum materials to standards.
